TERMS OF ENROLLMENT

I/We wish to enroll the above named child in the St Stephen's Episcopal Preschool for the full term of nine months, beginning in September and ending in May. A school day will be for the period of 8:45 a.m. until 12:30 pm. Children must be the proper age by October 1, 2015. For example, children wishing to enroll in the 3 year old class must turn 3 years old by October 1, 2015.

I/We agree to pay annual tuition for the chosen program for the full term of nine months. If for any reason the child needs to be withdrawn from the school during the school year, thirty days notice shall be given to the school in writing. Should the applicant desire to make the withdrawal without thirty days notice, the applicant agrees to pay a sum equal to one month's tuition. Tuition cannot be refunded for any reason. The applicant agrees to pay the tuition in 9 equal installments. Tuition is due on the 1st day of each month. There is a late fee of \$10.00 for payments received after the 10th of the month.

I/We agree to pay a nonrefundable registration fee of \$100.00 per child or \$150.00 per family to the school, and the school agrees to reserve one place in the chosen program for your child for the school year 2015-2016.
